

Terms & Conditions

Please read these terms and conditions carefully before participating in the Wedding & Lifestyle Treasure Hunt competition ("the Competition") organized by Wedding & Lifestyle Hub ("the Organizer"). By participating, you agree to be bound by these terms and conditions.

Travel Requirements for Treasure Hunt Participants:

Please be aware that some hunts may require you to drive on the last day. It's essential to familiarize yourself with the Treasure Hunt Guide, which will provide detailed information about locations and requirements. Make sure you're aware of where you need to be and plan accordingly.

1.1. By entering the Competition, you give the Organizer permission to share your information with sponsors/partners for the purpose of contacting you, sharing their services/specials/competitions/hunts, and providing relevant information.

1.2. Sponsors/partners may retain your records until you unsubscribe from their list. You have the right to unsubscribe from their emails/WhatsApp messages at any time.

Social Media Engagement:

2.1. The Competition utilizes social media platforms such as Facebook and others, where you may be asked to share, post, tag, and interact.

2.2. By sharing and participating on social media, you assist vendors in reaching a broader audience and potential clients.
